1 目的 Purpose

为体现 CGC 的公正性，使其他机构了解 CGC 认证收费的原则，特制定本说明。

The Introductions to reflect the fairness of CGC and let other institutions understand the principles of CGC certification fees, this note is formulated.

2 适用范围 Scope

本说明适用于 CGC 自愿性产品认证、国推认证，强制性产品认证和服务认证、管理体系认证。

The instruction apply to CGC voluntary product certification, national promotion certification, mandatory product certification and service certification, management system certification.

3 认证收费的说明 Instructions for certification fee

3.1 CGC 认证收费标准参照国家相关规定及《国家发展改革委关于重新制定强制性产品认证收费标准的通知》（发改价格[2009]1034 号）、国家认监委办公室关于转发《国家发展改革委关于放开部分检验检测经营服务收费》的通知（认办财（2015）10 号）制定。

收费标准中年金（认证管理费）指认证机构按照规定对获证后证书及委托人信息进行维护、更新以及认证服务跟踪过程中产生的费用。

CGC certification fee standard refers to the relevant national regulations and< the Notice of the National Development and Reform Commission on Re-establishing the Compulsory Product Certification fee Standard> (Price [2009] No. 1034), and <the notice of CNCA on forwarding the Notice of the National Development and Reform Commission on releasing Part of the inspection and testing business Service fees (Acknowledgement of Finance (2015) No 10) formulated.


Annuity (certification management fee) of the certification fee standard refers to the fees incurred by the certification body in the process of maintaining and updating the certificate and client information after the certification is obtained, as well as the certification service tracking.
